Nevada has concluded its 2009 Legislative Session (Session). During the Session, the Nevada Division of Insurance (Division) presented its bill, Senate Bill (SB) 388, which proposed several amendments to the Nevada Revised Statutes (NRS). One of the provisions of the bill created a Fund for Insurance Administration and Enforcement (Fund). The Fund is for the administration and enforcement of the Code. As presented, [SB 388](#) contemplated the effective date of the bill to be July 1, 2009. The effective date remained consistent throughout the legislative process. However, SB 388 died and [SB 426](#) was introduced in its place.

SB 426 was approved by the Governor on May 29, 2009, which became the legal effective date of the bill, not the originally contemplated date of July 1, 2009.

As a result, any license issued on or after May 29, 2009, must be assessed the \$60 "Insurance Administration and Enforcement Fee." The \$60 fee is required regardless of the date the application or application for renewal was received by the Division.

The Division will invoice those individuals and business entities whose licenses were issued on or after May 29, 2009, without being assessed the \$60 fee. The Division appreciates our licensees' cooperation in implementing the new law.
